The more you can recycle, the less you will have to pay for more expensive waste collections.



Don't forget – Remove any lids and rinse bottles, jars and cans before placing them in your burgundy bin.

Know your bins...



1280 litre bin H1430 x W1260 x D985mm (Holds approx. 16-19 bags)



1100 litre bin H1370 x W1250 x D990mm (Holds approx. 12-15 bags)



660 litre bin H1310 x W1250 x D720mm (Holds approx. 8-10 bags)



240 litre bin H1100 x W580 x D740mm (Holds approx. 4-5bags)



Storage and transportation

You must:

- store waste securely and transport your waste appropriately
- ensure that the person removing the waste is from either a local authority or a licensed waste collection company
- complete waste transfer notes to document all waste you transfer, and keep them as a record for at least two years. Failure to produce a valid waste transfer note may result in a Fixed Penalty Notice for £300. If taken to court, offenders may face a fine of up to £5,000.

You are responsible for all your waste from its production to its disposal. For further information on your responsibility as a business and producer of waste visit www.gov.uk/managing-your-waste-an-overview

Working at private households

If you operate a business at a private or domestic property such as childminding, then any waste you produced as a result of that business is classed as commercial waste.

This means you must make arrangements for its collection and disposal.

Hazardous waste

If you produce or handle hazardous waste (which maybe flammable, corrosive or ecotoxic), you must comply with hazardous waste regulations. Whenever hazardous waste is moved or transferred, it must be accompanied by a consignment note, copies of which must be held for three years. Waste Electrical and Electronic Equipment (WEEE) Regulations

The WEEE Regulations apply to electrical and electronic equipment. You must comply with the WEEE Regulations if you generate, handle or dispose of electrical waste. For further information on hazardous waste visit www.gov.uk/dispose-hazardous-waste

Your responsibilities

Business rates do not cover the removal of waste from business premises.

If you run a business, you are legally responsible for ensuring that the waste it produces or handles is stored, transported, treated, reprocessed and disposed of safely by a licensed waste carrier.

You must put all waste out for collection in the containers provided by Bolton Council or another licensed waste carrier.

If you put commercial waste on the street in unidentifiable containers like black sacks or put out more waste than you pay to have collected you could be prosecuted for fly-tipping and face a fine of up to £3 million for businesses, £95,000 for individuals or possible imprisonment.
