# **Childcare Sufficiency Assessment 2014**

#### 1. What is a childcare sufficiency assessment?

Under Section 6 of the Childcare Act 2006, local authorities are required by legislation to; 'Secure sufficient childcare, so far as is reasonably practicable, for working parents, or parents who are studying or training for employment, for children aged 0-14 (or up to 18 for disabled children).'

This duty includes the need for local authorities to make sure that sufficient childcare is available for some two year olds (those who meet the eligibility criteria), and all three and four year olds.

This assessment is a summary of the childcare position in Bolton and provides useful information for:

- **Parents** to understand the types of childcare on offer in Bolton, to look specifically at the number of childcare places by provider near to the family home and help to inform decisions about childcare options for their family.
- **Childcare providers** to understand the local childcare market and to help them make informed choices about future developments for their business.
- **Councillors and Executive Members** to have clarity on services available for local residents and to support the decision making process.
- Local authority officers to have a clear picture about childcare in Bolton, to tailor support for providers and to ensure that there is a balanced childcare market meeting local demand.

Childcare sufficiency is a judgement made by reviewing:

- **Childcare market analysis** type of provision, quality of providers, number of children, number of places, and the number of proportional places per 100 children in that age group.
- **Referrals to the Family Information Service for brokerage** (support to find services), where demand has not been met.
- Analysis of the local employment market to identify employment trends which may result in an increase / decrease in demand for childcare places.

The last childcare sufficiency assessment for Bolton was published for 2013.

#### 2. What childcare do we have in Bolton?

On the whole, Bolton has a balanced childcare market, despite the type of provision varying on an individual ward basis.

Childcare is provided through:

- Child minders
- Full day care
- Crèche
- Pre-school playgroups

- Out of school care
- Holiday care
- Wrap around care

Most childcare providers are registered to offer childcare places across age groups, subject to Ofsted regulations, and therefore is flexible to the needs of local families. Vacancy and capacity data in this report does not include nursery places based in schools for three and four year olds.

Appendix A shows all childcare providers operating across Bolton by provider type.

#### 3. Do we have enough childcare in Bolton?

#### 3.1 Childcare Market Analysis

#### 3.1.1 Places & vacancies

**Appendix B** breaks down the number of places and vacancies by provider type for each ward. Bolton has a healthy mix of childcare providers operating across the Borough and all wards currently have childcare vacancies which support parental choice when sourcing childcare.

#### 3.1.2 Proportional childcare rates

To help understand whether there is sufficient childcare, we also look at the number of childcare places as a proportion of the children who live in that ward - this tells us how many childcare places are available per 100 children.

The number of proportional places is calculated by dividing the number of full time equivalent (FTE) places in each ward by the number of children in that ward area. A breakdown of this information for each ward can be found in **Appendix C** and does not include wraparound childcare places for children in nursery classes.

A summary of this information for Bolton is displayed in **figure 1** below:

Although some wards to have a lower than average proportional childcare rate, all wards have vacancies, showing that some families may choose to:

- access childcare outside of the ward that they live in this is expected in wards where either parents travel further away from home to access work or where a family lives near to a ward boundary
- source part time childcare to fit in around work/training or informal care arrangements – this essentially allows two children to share one full time equivalent childcare place
- not access formal childcare eg if parents are not in work or training.

#### 3.1.3 Affordability

Childcare costs vary between providers across Bolton; the following information shows typical costs that are intended to give as a guide:

There are a variety of childcare options across the borough, each with their own pricing structure. Parents are provided with information on the financial support that they can receive to access childcare. There have been no reports made to the Family Information Service about families not being able to access affordable childcare.

#### 3.1.4 Additional activity to support targeted families

The local authority has a duty to ensure that there is sufficient childcare for all, where reasonably practical. To ensure that this happens, and also as part of the local authority's commitment to protect the most vulnerable, additional activities have taken place within the local childcare market to ensure that more targeted groups are able to have their childcare needs met. These are summarised in **figure 2** below.

School aged children and children needing holiday care	The local authority continues to provide both face to face, over the phone, online and a brokerage service for families. Bolton has recently seen the establishment of its first Child-minder Agency (CMA) so work is taking place to ensure that services for families are co-ordinated and complement each other.

#### 3.1.5 Informal childcare

In addition to formal childcare arrangements, and in the current financial climate, it is recognised that many parents utilise open access positive activity sessions as informal childcare. This is especially true for the families who have children aged 11-14 where formal childcare does not tend to be the preferred option for young people.

The overview of this informal provision is not reflected in **Appendix B** as activities for those aged over eight years do not need to be registered with Ofsted as it is classed as a play opportunity rather than childcare. It is not yet clear whether changes in local funding will have an effect on this in future years, and therefore create more demand for formal childcare.

Additionally, the Family and Day Care Trust 'Annual Holiday Childcare Survey' identifies the rising national trend of informal childcare through relatives such as grandparents, which also contributes to a lower demand for formal childcare.

#### 3.2 Referrals to the Family Information Service

The Family Information Service (FIS) offers a range of services to help families' access information, advice and guidance. These services are delivered:

- Face to face through children's centres and access points such as the one stop shop
- Over the phone through Access Bolton
- Via email through the families@bolton.gov.uk email address
- Online through the Bolton Council Webpage and Bolton's Local Directory.

Through these services, families can access information on support with childcare costs, tax credits and local childcare providers / services.

Bolton's Family Information Service offers a brokerage service to support parents to access childcare and short breaks. Over the past 12 months, the Service has been able to link up parents and childcare providers.

There have been two brokerage requests that were not resolved:

- Childcare commencing at 5.30am no local providers operating at this time
- Childcare for the school Christmas holidays this request was made close to the holiday period and the local childcare providers did not have vacancies for the specific days / times required.

Both of these requests were restricted by the distance that the families could travel to access childcare.

#### 3.3 The local employment market

It is anticipated that Bolton's population aged 16-64yrs will be the most likely to require childcare to enable them to access employment or training. As such, the percentage of out of work benefit claimants is analysed to support the childcare sufficiency assessment.

Bolton's working age population has reduced, as has the percentage of people claiming out of work benefits. A summary is shown in **figure 3** below. This suggests that there may be increased demand for childcare. However, there are currently enough childcare vacancies to satisfy local childcare demands across the Borough.

#### 4. Support for Bolton's childcare providers

The support offered to childcare providers from Bolton Council is broken into three distinct areas:

#### • Pre-registration information and guidance / universal promotion


This is delivered by the Family Information Service who explain processes to prospective providers and Workforce Development who deliver, or commission, pre-registration training.

The Family Information Service promotes all active childcare providers, dependent upon the permissions that the provider gives on registration – some child-minders ask not to have their home address shared for example. Promotion is in the form of face to face information in access points, phone enquiries / postal service through Access Bolton and online promotion through the local directory. All of this promotion is free of charge. The local authority also uses social media to encourage families to access online information through the Bolton Council website / local directory at key points (eg school holidays).

#### Developing quality provision

Delivered by the Early Years and Childcare Team, challenge and support visits with all local providers registered with Ofsted take place twice a year. These visits are more frequent where a provider's inspection grade falls below 'good'. Sessions are an opportunity to share good practice, support the interpretation of Ofsted guidance, offer business development support, identify training needs and produce action plans where necessary.

Ofsted judgements have varied throughout the year, judgements as at the end of the autumn term are shown in **figure 4** below.



All providers expressing an interest in providing free childcare and early education places for two year olds are required to go through an Expression of Interest (EOI) process. This ensures that the provider meets the national criteria and is an opportunity for the Early Years and Childcare Team to also offer development support.

In 2014-15, legislation was introduced to allow the formation of Child Minder Agencies (CMAs) in the UK. In their establishment, it is expected that child minder agencies will support child minders with training and business advice and provide parents with easier access to high-quality childcare. It is entirely voluntary for child minders to join agencies, and for parents to use them.

Bolton's first child minding agency became operational from September 2014; work is currently taking place between the local authority and the CMA to ensure continuity for parents.

#### • Continuing professional development (CPD)

In a joint approach between Workforce Development and the Early Years and Childcare Team, CPD opportunities are offered to all settings registered with Ofsted in Bolton. CPD comes in many formats including formal training, online training and work shadowing for example. The CPD programme is developed as a result of demand from childcare providers across Bolton and also as a result of local and national policy changes.


#### 5. Gaps in childcare and how these will be addressed

Overall, Bolton has sufficient childcare to meet demand.

The two instances of unresolved brokerage cases were in part restricted by individual circumstances of the families. However, as a local authority we will continue to:

- Work with Job Centre Plus to support parents to access affordable employment / childcare opportunities
- Support families by offering a brokerage service to make links with providers where needed
- Work with providers to share trends coming through enquiries (eg childcare needs at different times of day or demand that we have not been able to satisfy)
- Utilise our data management information to track childcare enquiries and work with providers to help shape the future childcare market.
