

Table 1 below shows how the Council Tax has changed year on year since the Adult Social Care Precept was first introduced. The regulations permit the precept to be increased by a percentage of the previous year's whole bill in the same way that the general council tax levy is increased. You will see that for 2021/22, the precept increased by 2.5% or £63.17, this being 2.5% of 2020/21's basic charge (£2,526.96).

However, Council Tax Regulations state we have to show the total cumulative amount raised specifically for Adult Social Care as a line on the council tax bill. From the table above this is shown in table 2 below;
