

Table 1 shows the changes in Council Tax each year since the Adult Social Care Precept was introduced. The regulations permit the precept to increase by a percentage of the previous year's whole bill in the same way that the general council tax levy is increased.

You will see that for 2024/25, the precept increased by 2.00% or £56.25, this being 2.00% of 2023/24's basic charge (£2,812.72).

Please note that percentage changes to all charges are shown to 1 decimal place on Council Tax bills in line with statutory requirements.

However, Council Tax Regulations state we are required to show the total cumulative amount raised specifically for Adult Social Care as a line on the council tax bill. From the previous table this is shown in table 2 below:
