TC122/19 THE ATTENDANCE OF THE DIRECTOR OF PLACE RE THE WESTHOUGHTON TOWN CENTRE STEERING GROUP

The Director of Place explained the work of the Westhoughton Town Centre Steering Group and the possible benefits to Westhoughton, and answered questions from the Town Council.

TC123/2019 TO DISCUSS PLANNING & DEVELOPMENT MATTERS AND TO APPROVE ANY ACTION

(a) TOWN COUNCIL COMMENTS ON PLANNING APPLICATIONS

The Town Council requested that its comments on the following Planning Applications are placed before the Bolton Council Planning Committee:

- 06335/19 The Town Council raised no objections
- 06366/19 The Town Council raised no objections
- 06307/19 The Town Council requested that the Bolton Council Planning Committee or the Planning Officer determine the application because there was insufficient information on the Planning Portal
- 06253/19 The Town Council requested that the Bolton Council Planning Committee or the Planning Officer determine the application
- 06410/19 The Town Council raised objection because of the detrimental impact on wildlife and Pennington Brook, additional traffic from the dwellings on the already congested highways, insufficient places at Doctors and Schools, and a similar application has been refused before
- 06443/19 The Town Council requested that the Bolton Council Planning Committee or the Planning Officer determine the application
- 06447/19 The Town Council requested that the Bolton Council Planning Committee or the Planning Officer determine the application
- 06324/19 The Town Council requested that the Bolton Council Planning Committee or the Planning Officer determine the application. The Town Council is concerned at the possible impact on the rear unadopted street and the ability of the refuse wagons to access the rear street

- 06413/19 The Town Council would prefer to be consulted on the Planning Application for the complete renovation of Westhoughton Town Hall rather than separate, small applications. However, if the application is approved, the Town Council requests the retention of the historical features and asks that the glass/stained glass is removed and replaced in the new windows
- 06503/19 The Town Council requested that the Bolton Council Planning Committee or the Planning Officer determine the application and is concerned at the impact on the neighbouring properties because of the length of the proposed extension
- 06485/19 The Town Council raised objection because of the number of dwellings, the increase in traffic from the dwellings on the already congested highways, the detrimental impact on wildlife and the Hall Lee Brook nature reserve, and there are insufficient places at Doctors and Schools

TC125/2019 TO NOTE THE MINUTES OF THE PLANNING AND FINANCE & GENERAL PURPOSES COMMITTEE MEETING HELD ON MONDAY, 8TH JULY, 2019

Resolved that the minutes of the Planning and Finance & General Purposes Committee Meeting held on Monday 8th July, 2019, as circulated, be noted by the Town Council.

The Town Clerk informed the Town Council of illegal acts and explained that she had been unable to correct the matter at the meeting because she had not been consulted beforehand and it was inappropriate to stop the meeting to check legalities because guests were present:

PFGP94/2019 – Resolved that the Town Council suspend non-mandatory Standing Orders in accordance with Standing Order No. 32a in order to allow Cllr Speight – the member of the public to take part in the Agenda Item:

(a) This was illegal as suspending non-mandatory Standing Orders does not allow a member of the public to take part in an Agenda item

- (b) Cllr Speight is sanctioned for lying about the Town Clerk in the Bolton News and for harassing her for more than 4 years and as a result of the sanctions he cannot take part in Committee or Sub-Committee Meetings. The sanctions link in to Duty of Care to an Employee - National Employment Law, which is paramount to Town Council Standing Orders/Agenda Items
- (c) Councillors who voted for this course of action had breached the sanctions Duty of Care to Employee – National Employment Law and Code of Conduct 2.9 – Duty to uphold the Law. Cllr Speight knows that he is sanctioned and should not have taken part in the Agenda item.

The Town Clerk pointed out that the above action was unnecessary as Cllr Speight, the member of the public, could have asked his questions under the Agenda Item – Adjournment to Allow Public Question Time and answers would have been given during the Agenda Item PFGP94/2019.

The Town Clerk requested that any Councillor who wishes to suspend a Standing Order consult her first, so that she can check the legality.

Resolved that the Town Clerk check if the costing for renovating footpath Westhoughton 001 is correct and request a costing for the renovation of the footpath from Cornerbrook – the old football field, Slack Lane.

Cllr Mrs J M Nicholson left the meeting.

TC129/2019 DISCUSSION ON INVITING A FAIRTRADE REPRESENTATIVE TO A TOWN COUNCIL MEETING AND TO APPROVE ANY ACTION

The Town Clerk had produced a report explaining that the Town Council has no powers to spend money on Fairtrade or legally finance or award a grant for Fairtrade as it does not benefit Westhoughton or its residents. Also, the Town Council cannot comply with Goal 1. The Town Council has no powers to influence whether or not shops sell Fairtrade products, businesses, organisations and residents purchase Fairtrade products.

The meeting was adjourned whilst a Fairtrade representative explained the work of the Fairtrade Foundation in Westhoughton and she believed that a simple resolution would be sufficient. The meeting was re-convened. Resolved that the Town Clerk compile a simple resolution supporting the Fairtrade Foundation.
