The zoo is in part a working open farm park and part Zoo and has been established and expanded over seveal years with additional commercial developments and the addition of an eclectic group of exotic species now on site. The business is owned by one family through a limited company and offers an educational and recreational experience to view the processes of a milk and meat producing farm as well as breeding several rare domestic species and exhibiting a variety of birds, small mammals and reptiles. The attendance is approaching 200K persons per annum and now operates almost entirely on a pre-booking system to allow better management of the public. It is situated in a large public owned park in Bolton Lancs, and is currently leased to the zoo licence holder.

The Pre-Inspection Audit form was completed and received with very comprehensive background material and other information was mostly available on the day of the Inspection.

The Inspectors thank the Proprietor and the administrative staff for the completion and submission of

the PIA and for making other information available on the day.

Most of the previous conditions have been completed, some are still not complete or are in progress, and there is an ongoing program of maintenance and development taking place although this seems a little ad hoc dependent on time, resources available, and planning permissions. Paper work and administrative practice is now very much improved but still has a somewhat random access process which needs tidying up.

Older areas of the zoo formerly showing some wear and tear but still serviceable in some cases,

have been upgraded and new developments are completed to a high standard. Additional maintenance

and repair/replacement of specified areas must be planned and undertaken.

Staff appear qualified and well briefed for their tasks. The education programme is well considered and itemised for use for public education. Subsequently the educational programme is under regular review.

Zoo talks are delivered by management and senior keeping staff and are carried out in the schoolroom

as well as out in the display

Overall the zoo is much improved since the last inspection and management and staff are to be commended for the improvements seen , however ,this improvement must be maintained to ensure future compliance . Particular attention must be paid to the final new revised standards which may require substantial review of some aspects of the Zoo, specifically, they are likely to require more

active participation by the zoo in conservation and research.

The Zoo continues with regular renewals and re-developments which improve both the welfare of the animals kept and the ambience and recreational value for the visitors. The development plan needs to take into account, trends and changes expected by the visiting public as animal welfare perception

influences the future management of the collection.

The inspectors commend the ongoing programme of renewals and new developments.

It is vital that the zoo licence holder understands and complies with, the conditions placed on the licence, and with Directions notified to the Zoo. Failure to complete Directions in particular, will in some cases, lead to closure of parts of , or in extremis ,the whole zoo. If this were to be the case, then the welfare of the animals and the commercial viability of the Zoo would suffer major jeopardy.

Recommendations:

1. The ethics committee is well supplied with a variety of skills, but all of those involved are connected in some way with the operation of the zoo. It is recommended that at least one "external" member who has no direct connection to the Zoo management be recruited to ensure balanced opinions are

expressed. Minutes of all meetings should be kept.

- 2. It would be helpful to management and to Licensing Inspectors if the numbers of school age visitors / outreach students who are benefiting from the education programme could be assessed and if some feedback directly from the schoolchildren could be considered in addition to the formal response from supervising teaching staff. Overall approximate annual attendance numbers should be assessed. 3. It is recommended that use of portable electrical extension sockets in proximity to animals should only be in temporary or emergency cases. Sockets in permanent use should be safely fixed.
- 4. The trees in the zoo are not formally monitored at present and no written record of tree inspections and any actions taken as a result of such is present. It is recommended that regular tree inspections

take place and written records be kept at the zoo. 5. The rabbits are now not kept in hutches and are free to range in their enclosures. Additional improvement to welfare would be achieved by some degree of exposure to outdoor environments where possible.

6. A review of the locations and numbers of fire extinguishers at present on the premises is recommended, following advice from the Fire service or other competent advisers.

The route of travel for the public in the large barn is not well indicated. Some Directional Arrows either on the floor or affixed to walls or gates, could assist in crowd control.

8. Staff appraisals should be carried out on at least an annual basis and outcomes recorded.

- 9.Day Diaries although present record mainly only items and reports of problems with animals and/or enclosures. It is recommended that each day following review, it is recorded that "no", or "no other" problems are noted in the collection for that day. More other pertinent minor notes could also be recorded in this log, so that a "snapshot" of the daily circumstances can be illustrated.
- 10. Information signage is comprehensive and fulfills all requirements of the SSSMZP. This could however be reviewed so as to emphasise the required elements and a larger font size be utilised where signage is placed more remotely from the viewing public. New signage is being introduced as part of an ongoing programme
- 11. It is recommended that Staff tasked with monitoring hand washing of the public on exit from the large barn seek to deter the public from backtracking into the barn after washing or if they so do, ensure that a second washing opportunity is presented. The inspectors would remind the zoo licence holder that as the Zoo is substantially also a Farm to which the public have access and on which they also, in some areas, have availability for direct contact with animals, the licence holder should be aware of, and take notice of, other guidance from competent bodies (e.g Access to Farms, March 2021, Industry Code of Practice V.3). This draws attention to the possible public health risks to the Public when visiting farms: quote;

 "Arrange adequate and appropriate levels of supervision in "animal contact" areas for any time while they are

"Arrange adequate and appropriate levels of supervision in "animal contact " areas for any time while they are being used. The number of supervisors will depend on the size of the area and the number of visitors permitted or

expected in that area at one time. Depending on the level of risk and other control measures in place, consider whether supervision is needed as part of your control measures for "look and see" areas".

"Ensure that children are supervised while they wash their hands. Part of this responsibility rests with Parents or teachers, but in some cases, Staff may need to offer help in supervision, or remind people to wash hands ". (End

12. Veterinary records for the animals kept are present in outline at the zoo, but the details of any treatments carried out either at the zoo, or at the veterinary surgery should also be kept alongside the animal's history in the zoo. (See also conditions).

- 13. It is recommended that the current records on computer are reviewed and the layout of information is improved such that access to the information held is made as clear and easily accessed as possible.
- 14. The fence at the paddock currently holding Rheas is wide mesh. The animals currently held are young and at present are presenting no hazard to the public, but regular monitoring of behaviours should take place and any future aggressive changes should be controlled either by moving to alternative accommodation or provision of stand -off barriers at this enclosure.

This Condition must be completed within 3 more than the date on which this Condition takes effect. (NOTE: there appears to be some confusion in the current lease as to where the responsibility for such maintenance lies . Irrespective of this the inspection and issue of the subsequent certificate is required under both the ZLA and probably under H&SaWA regulations and compliance must be ensured). 2. There was no evidence of excessive pests or vermin present on inspection, however there was no indication or records of the method by which such risk is controlled. In order to comply with Section 1A(e) of the ZLA 1981 and Section 3.17 of SSSMZP, the Zoo licence holder must produce to the Licensing Authority evidence that a program of control for pest and vermin has been put in place at the Zoo and written reports of its effectiveness be kept at the zoo. Additional Conditions (if appropriate)

3. The veterinary care plan for some animals on the zoo was present, but appears to cover only routine endo- and ecto-parasite treatments and vaccinations of animals, this must be reviewed to include ,where appropriate, screening of potential zoonotic disease and outline geriatric care plans for ageing or chronically disabled animals in the collection. Thus;

In order to comply with Section1A(c) (ii) of ZLA 1981 and Section 3.9 ,3.10 and 3.11 of SSSMZP, the zoo licence holder in conjunction with the zoo's Veterinary Surgeon must review and update the current veterinary care plans, for the animals kept at the zoo to include a comprehensive plan for each group and /or species of animals present, to include where appropriate geriatric / disabled care and monitoring for zoonotic disease. In addition copies of animal treatment records and evidence of the Veterinary Surgeon's CPD, must be kept at the zoo. This condition must be completed within 6 months from the date on which this condition takes effect. This condition must be completed within 6 months from the date on which this condition takes effect.

4. Various freezers are in operation and use in the collection, but not all are externally identifiable as to their contents. Thus;

In order to comply with Section 1 A (c) (ii) of ZLA 1981 the zoo licence holder, must mark each freezer in use in the zoo with a label which appropriately identifies the use and contents held. The label to conform with accepted practice and any applicable health and safety regulations currently in force. (e.g animal by products regs).

This condition must be completed within 3 months from the date on which this condition takes effect.

5. In the large barn several animals (e.g.Adult pigs) are signed to indicate a possible bite risk, but the gates separating the public from the animals could still allow bite risk through the wide bars. Thus:

In order to comply with Section 1A(d) of ZLA 1981 and Section 8.6, 8.9 of SSSMZP, The zoo licence holder must prevent the public being able to place their hands (or other parts of their body) through the gate bars of the enclosures containing animals where a bite risk exists. This may be done by meshing the gate fronts or an internal of external stand off barrier, or other effective action which minimises this risk.

Directions

Where there has been non-compliance with an existing condition on the current zoo licence the licensing authority must issue a direction indicating the steps required to be taken to ensure the original condition is met. The existing conditions on the zoo licence included the Section 1A conservation measures, the standard additional licence conditions, and any that may have been added as a result of previous zoo inspections.

The inspecting team recommends that the following directions are issued to the zoo:

1. During the inspection of the zoo on 19th July 2022, it was noted that the development and collection plans for the zoo are incomplete. The development and collection plan are present at the zoo but are limited in size and scope. They also as yet, do not take note of some trends in modern keeping and display of some animals and as yet give no indication of how the proposed update of the SSSMZP may effect this zoo. Thus:

In order to comply with Section 1A (c) & (a) of ZLA 1981 and Sections 1, 2 & 7 of SSSMZP the current collection and development plans must be revised to indicate the future content of the collection and the measures to be taken to properly accommodate the animals in that plan taking into account required modern practice and standards for keeping of all animals in the collection. This must include an approximate time scale for redevelopments/refurbishments of enclosures to be built or renovated in the zoo. A copy of the completed plan to redevelopments/ refurbishments of enclosures to be built or renovated in the zoo. A copy of the completed plan to be lodged with the licensing Authority.

The plan must be completed within 6 months of the date from which this Direction takes effect.

At present this Direction does not require the closure of any specific area of the Zoo

2. During the inspection of the zoo on 19th July 2022 it was noted that in some areas nylon baling twine is being

used to hold and /or hinge enclosure gates. This is not acceptable, thus:

In order to comply with Section 1(A) (c) (i) of ZLA 1981 and Sections 2.3, 2.8 of SSSMZP, the zoo licence holder must ensure that all gates, fencing, or other methods of ensuring security of enclosures, where baling twine is in use as a closure or support fixture, must be firmly fixed using appropriate materials of sufficient strength to meet the Standard.

This Direction to be completed within 1 month of the date from which this Direction takes effect.

The zoo is not required to be closed during the period of this Direction.

3, It was noted during the inspection on 19th July 2022 that: In the large barn and in some instances in other areas of the collection the entrances to enclosures are fixed solely by a spring loaded bolt system. These fixtures are mostly in public areas and are not a locked fitting.. Thus:

In order to comply with Section1 (A) (c) (i) of ZLA 1981 and Section 2.3, 2.8 of SSSMZP, the zoo licence holder must secure these access gates by additional means (Such as chain & lock), so that they cannot be opened by the public and thus allow escape by the animals contained and also deter entry by the public into the enclosures.

This Direction to be completed within 2 months of the date from which this Direction takes effect.

At present the zoo is not required to be closed during the period of this Direction.

4. It was noted during the inspection on 19th July 2022 that; Although practices of the escapes procedure had taken place in the zoo, the requirement for 4 such practices to take place annually had been fulfilled, but only one (non escape) emergency drill had taken place. Thus

In order to comply with Section1(A) (d) of ZLA 1981 and Section 8.3 of SSSMZP, the zoo licence holder must ensure that full practice emergency drills must be carried out at the zoo during any consecutive 12 month period.

All such practices must take place on the zoo and "desktop" practices do not qualify. Such routine emergency drills must ensure that public safety is prioritised.

This Direction to be completed within 12 months of the date from which this Direction takes effect

This Direction to be completed within 12 months of the date from which this Direction takes effect.

At present the zoo is not required to be closed during the period of this Direction.

5. It was noted during the inspection on 19th July 2022 that in some food preparation areas (Particularly the milk feeding area in "pets corner" of the large barn), insects were seen (Flies). This is not acceptable in food preparation

In order to comply with Section 1A(c) (ii) of ZLA 1981 and Section 1.3 b&c of SSSMZP the zoo licence holder must review insect controls in all food preparation areas and ensure effective controls are in place and any mechanical device so used is in full working order.

This Direction to be completed within 3 months of the date from which this Direction takes effect.

At present the zoo is not required to be closed during the period of this Direction.

6. It was noted during the inspection of 19th July 2020, that in some areas (particularly in the Pets Corner of the large barn) Cobweb silks were seen in some cases holding dust and hay/straw fragments. These indicate inadequate cleaning and a possible fire risk.

Thus: In order to comply with Section 1 A (c) (i) of ZLA 1981 and Section 2.7 of SSSMZP the zoo licence holder must, as part of the regular cleaning routine of buildings and enclosures in the zoo, include the brushing and removed of such and collected debris in such a manner that the promises are clean of such and that any

removal of cobweb silks and collected debris in such a manner that the premises are clean of such and that any collateral fire risk is reduced.

This Direction to be completed within 1 month of the date from which this Direction takes effect.

At present the zoo is not required to be closed during the period of this Direction.
