#### Important Information:

This Privacy Notice provides additional information for people accessing Neighbourhood Services. It is important that you read this Privacy Notice, together with any other privacy information we may provide on specific occasions when we are collecting or processing personal information about you, so that you are aware of how and why we are using such information.

The information collected and held will vary depending on the service used.

Bolton Council are the data controller for the personal data we collect from you. Under the UK General Data Protection Regulation, this Privacy Notice provides you with information.

If you do not provide us with the information that we request, we may be unable to deal with your complaint, or query, or carry out any investigations on your behalf.

#### **Neighbourhood Services:**

We liaise with local people and involve neighbourhoods in giving them a say in how we can improve our services.

Keeping our neighbourhoods safe is our top priority, and therefore, we carry out joint - partnership working with other key agencies, such as, the Police, Social Services, NHS, and the Fire Service etc. to help keep our neighbourhoods safe.

Consequently, information sharing is essential to help develop and improve our local neighbourhoods.

# How is your personal information shared/processed?

In accordance with Schedule 2 part 1 of the Data Protection Act 2018, your information may also be shared with other Local Authorities' Enforcement Agencies to investigate taxation or crime.

Information will also be shared in the courts, and publicly if you act as a witness in a court of law, or if Bolton Council is taking criminal proceedings against you, that may lead to a Fix Penalty Notice, or a prosecution.
