

Partners Consultation on Bolton's Proposed Change to the Governance of Start Well Centres





Rationale for the consultation

The Start Well Service priority is to improve outcomes for children in their early years and beyond,

With revised national policy, a focus on the first 1001 critical days; an emphasis on placebased services, we want to develop neighbourhood Start Well Family Hub and 'integrated 0-19 services'.

As part of our statutory duty we must consultant on the Start Well Centre governance and any proposed changes.

To undertake a public consultation on the Start Well Centres Governance to be aligned with the Council's 1,3,9 neighbourhood model and to redesignate the Start Well Centres into Start Well Family Hubs.



Why is this happening?

- To create Start Well Family Hubs and to ensure cohesion in service delivery it is proposed that the Bolton Start Well Centre reach areas are aligned with the Council's 1,3,9 neighbourhood model:
 - 1 locality (Bolton),
 - 3 districts (North, South, West)
 - 9 neighbourhoods (Turton, Breightmet/Little Lever, Crompton/Halliwell, Deane/Rumworth, Central/Great Lever, Farnworth/Kearsley, Chorley Roads, Horwich, Westhoughton).
- This would involve the merger of the three statutory Early Years Partnership Boards (Advisory Boards) into one, with the retention of elected member representation.



It is proposed that responsibilities for Start Well Centre buildings be realigned as part of the Start Well Family Hub and 'integrated 0-19 services' functions.

They will operate longer opening times, including evenings and weekends, to enable a flexible approach to meet the needs of children, young people and families.

This will support Targeted Early Help and other services to provide a timelier response to help prevent escalation 'out of hours' and gives families access to the service at a suitable time for them, thus improving uptake and engagement.

BoltonWhat are you being consulted on?

Rename the Start Well Centres, calling them Start Well Family Hubs:

The hubs will then support families from pregnancy onwards - until their children are 19 years old, or older for those with special needs

Changing the way the governance boards work, by having a Start Well Family Hub in each neighbourhood, reporting to one boroughwide board, instead of three.

Include the Bright Meadows Centre in Breightmet as a Start Well Family Hub, alongside the other 17 centres.

Bolton What will this look like?

The aim is to move to a Group Delivery Model. This would retain all three Statutory Children's Centres under one shared leadership and management arrangement.

Currently the three Statutory Start Well Centres have a Head of Centre managing each locality and associated buildings.

The Governance for each Start Well centre reach area is to an Early Years Partnership Board in each locality.

By moving to a group Delivery model the Governance will move to one boroughwide Early Years Partnership Board and a shared leadership across all the centres.

Group Delivery Model

Each main Children's Centre no longer has its own manager but has shared leadership and management and shared services.

Request the redesignation from Start Well Centres (0-5) to Start Well family Hub (0-19). This will then give Bolton the opportunity to develop the Start Well Family Hub and 'integrated 0-19 services' functions in partnership.
