Westhoughton 173 Off the Pewfist:

Part A; Cut back and clear vegetation between the Pewfist and The Hoskers. Pewfist end; approx. 10m, scrape off mud to gate posts and apply stone to alleviate pooling. (red line on attached plan) £620

Westhoughton 173 Off the Pewfist:

Part B; Continuation of part A; scrape off mud for further approx.120m to allow water to drain off the side (green line on attached plan) £680

Westhoughton 173 Rear of Sandalwood:

Part C; approx. 30m; scrap off mud and stoning up and compact as necessary (black line on attached plan) £780

To cut vegetation along 49 or approx. 10,000m of rights of way in Westhoughton once a year, undertaken by a Council approved contractor. Cost for a second cut of vegetation in Westhoughton would be £2845.76

Total cost: £4925.76

(Westhoughton 173 Parts A,B & C can be optional, and parts removed as necessary to be as near as possible to the budget allocation). The PRoW team might be in a position to cover any short fall.

An alternative to the above - **Westhoughton 105 Length 97m**: Off Church Street between fields: put down weed control fabric and stone up and compact to give a walkable width of 1.5m (red line on attached plan) £4750.00. Because this option is over budget, further discussions would appear necessary.
