THE BOROUGH COUNCIL OF BOLTON (PUBLIC FOOTPATH NO. 385 BOLTON (PART)) PUBLIC PATH DIVERSION ORDER AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2019

This Order is made by the Borough Council of Bolton ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act"). It appears to the Authority that in the interests the owner of the land crossed by the footbath described in paragraph 1 of this Order that it is expedient that the line of the path should be diverted.

This Order is also made under Section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the Authority that the Definitive Map and Statement of the Public Rights of Way for the Borough Council of Bolton require modification in consequence of the occurrence of an event specified in Section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the Map and Statement.

Peel Land and Property Group Management Limited, Peel Dome, Trafford Centre, Manchester M17 8PL has agreed to defray any compensation which becomes payable in consequence of (1) the coming into force of this Order and (2) any expenses which are incurred in bringing the new site of the footpath into fit condition for use by the public.

BY THIS ORDER:

- 1. The public right of way over the land which is situated to the south of 30 Lambton Street, Bolton, BL3 3LG and shown by a bold black continuous line on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up as from the date the Authority certifies that all necessary works to bring the footpath described in Part 2 of the Schedule into a fit condition for use have been completed and thereupon the Borough Council of Bolton definitive map shall be modified by deleting from it that public right of way.
- Notwithstanding this Order all statutory undertakers shall continue to have existing rights of access to and egress from any apparatus equipment and plant accessible over the land referred to in Part 1 of the Schedule.
- 3. There shall at the end of 21 days from the date of conformation of this Order be a footpath over the land situate to the south of 30 Lambton Street, Bolton, BL3 3LG, described in Part 2 of the Schedule and shown by a bold black broken line on the map contained in the Order, and thereupon the Borough Council of Bolton definitive map shall be modified by adding that path to it.
- 4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.
- 5. The Definitive Statement of the Public Rights of Way for the Borough Council of Bolton shall be modified as described in Part 4 of the Schedule,
