### SECTION 4: First aid measures

#### 4.1. Description of first aid measures

<b>General information</b>	In case of accident or if you feel unwell, seek medical advice immediately (show the label where possible). Advice for Medical Doctors: Bromadiolone is an indirect anti-coagulant. Phytomenadione, Vitamin K, is antidotal. Determin prothrombin time not less than 18 hours after consumption. If elevated, administer Vitamin K1 until prothrombin time normalises. Continue determination of prothrombin time for two weeks after withdrawal of antidote and resume treatment if elevation occurs in that time.
<b>Inhalation</b>	Unlikely to present an inhalation hazard unless excessive dust is present. Move to fresh air. Obtain medical advice immediately. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Loosen tight clothing such as collar, tie or belt. Get medical attention if symptoms are severe or persist.
<b>Ingestion</b>	Rinse mouth thoroughly with water. Do not induce vomiting. Get medical attention immediately.
<b>Skin contact</b>	May cause irritation to susceptible persons. Immediately take off all contaminated clothing. Wash immediately with plenty of soap and water and seek medical advice
<b>Eye contact</b>	May cause eye irritation to susceptible persons. Rinse immediately with plenty of water and seek medical advice. Rinse cautiously with water for several minutes. Get medical attention if irritation persists after washing.
<b>Protection of first aiders</b>	First aid personnel should wear appropriate protective equipment during any rescue.
