a. Questions from Richard Bates:

- 1. Over the past 4 years, since May 2019, how much has each Mayor been paid to represent Westhoughton in Civic duties? Broken down by each mayor please.
- 2. Does this money come from the extra Westhoughton Precept, paid for by residents in Council Tax? If not, where does this come from?
- 3. Over the past 4 years, since May 2019, how much has each Mayor raised for charities, broken down by Mayor and charity, please?
- 4. Has any extra money been requested by the Mayor to hold events pertaining to their Mayoral status, over the past 4 years (since May 2019)?
- 5. How many events over the past 4 years, since May 2019, has each Mayor

attended. If the Mayor cannot attend, has the deputy stood in their place?

b. **Question from James Copper:** What CCTV provision was on the Library Street and Ditchfield Gardens car parks following the recent vehicle damage?

Town Council response: Mr Copper was informed that these car parks are under the control of Bolton Council and are not covered by cameras owned by Westhoughton Town Council. As additional information, Bolton Council has been contacted regarding the recent damaged cars and they have replied to say that they are happy for the Town Council to expand CCTV coverage to the car parks, but would provide no funding toward this. The issue of CCTV and the possibility of improving the current system will be an agenda item for Monday 12 June.

c. Question from Anna Marie Watters: As BLGC is no longer delivering activities for the children of Westhoughton from the Central Drive site, The Hub at Westhoughton would like to apply for the funding previously designated to BLGC to put a range of activities forward for the children. There will always be an educational aspect to the activity and we would like to ask whether this is something the town council would be interested in funding before we put a detailed plan together.

9. Establishing working groups

Each working group to consist of 6 members (a third of the council) made up of 3 Liberal Democrats, 1 Labour, 1 Conservative and 1 Westhoughton First.

a. Town Centre CCTV working group

To establish a working group to review the current CCTV system, to consider any improvements or replacement of the scheme or any possible expansion of the scheme to cover other areas of the town centre, to review the current and future costs and to report back to the Town Council.

b. Defibrillators working group

To establish a working group to review the defibrillator coverage across Westhoughton, to identify any gaps in the coverage and make recommendations to eliminate gaps and any potential costs in doing so. To report back to the Town Council.

c. The Big Plant working group

To establish a working group to consider locations and costs for planting schemes across Westhoughton (i.e. on grass verges), to work with voluntary and residents groups, schools, other organisations and Bolton Council, as part of a "Big Plant" event from October onwards, to improve the appearance of Westhoughton in the spring. To report back to the Town Council.

10. Renew contract with Play and Youth Services and to consider any additional services that they could provide using the funding previously earmarked for BLGC.

11. Market Street planters

Due to the ongoing footpath works on Market Street, which will last until November and requires removal of the beehive planters, it is proposed that planting is postponed this year. This would free up funding from this budget heading.

12. Items for reporting

- Bolton Council Youth Consultation on serious violent crime the deadline for responses is 21 July. This means it can be placed on the Town Council agenda for Monday 26 June if the Town Council wishes to discuss it.
- Bolton Transport Strategy workshop dates this is a borough wide policy document for transport priorities across Bolton. They wish to know possible dates between July and September for a meeting or to attend a Town Council meeting.
