#### THE DOGS EXCLUSION PUBLIC SPACES PROTECTION ORDER (2023)

The Borough Council of Bolton in exercise of its powers under Sections 59, 60, and 72 of the Anti-Social Behaviour, Crime and Police Act 2014 ("the Act") hereby make the following Order: -

**1.** This Order shall come into operation on the 20<sup>th</sup> October 2023 and shall have effect for three years thereafter, unless extended by further Orders under the Council's statutory powers.

**2.** This Order relates to public spaces as specified on the Order Schedule, hereinafter referred to as 'the Restricted Area'

**3.** - (1) Except as provided in Article 3(2) of this Order, a person in charge of a dog shall be guilty of an offence if, at any time, he takes the dog onto, or permits the dog to enter or to remain on, any land to which this Order applies unless —

- (a) he has a reasonable excuse for doing so; or
- (b) the owner, occupier or other person or authority having control of the land has consented (generally or specifically) to his doing so.

(2). The restriction in Article 3(1) of this Order shall not apply to a person who-

- (a) is registered as a blind person in a register compiled under section 29 of the National Assistance Act 1948; or
- (b) is deaf, in respect of a dog trained by Hearing Dogs for Deaf People (registered charity number 293358) and upon which he relies for assistance; or
- (c) has a disability which affects his mobility, manual dexterity, physical co-ordination or ability to lift, carry or otherwise move everyday objects, in respect of a dog trained by a prescribed charity and upon which he relies for assistance.
- (3) For the purposes of this article
  - (a) a person who habitually has a dog in his possession shall be taken to be in charge of the dog at any time unless at that time some other person is in charge of the dog; and
  - (b) each of the following is a "prescribed charity"—
    - (i) Dogs for the Disabled (registered charity number 700454);
    - (ii) Support Dogs (registered charity number 1088281);
    - (iii) Canine Partners for Independence (registered charity number 803680).

**4.** The Council is satisfied that the conditions set out in Sections 59, and 72 of the Act of 2014 have been satisfied and that it is in all the circumstances expedient to make this Order for the purposes of combatting nuisance within the Restricted Area caused by dogs, activities which have had a detrimental effect on the quality of life of those in the locality. The effect or likely effect of this is of a persistent or continuing nature such as to make this unreasonable and justifies the restrictions imposed by this Order.

**5.** A person found in breach of this Order shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale.

**6.** If any interested person desires to question the validity of this Order on the grounds that the Council has no power to make it or that any requirement of the Act has not been complied with in relation to this Order, he or she may apply to the High Court within six weeks from the date on which this Order is made.
