### Statement of reasons

- 1. A planning application has been received and has been approved for two electric vehicle charging points outside the shops on Highfield Rd. An area which has a demand for on street parking but also has a turnover with visitors due to the varied nature of the business premises.
- 2. This proposal will introduce the associated restrictions, amending existing restrictions to accommodate the new bays.
- 3. To secure the expeditious, convenient and safe movement of traffic in pursuance of the Authority's duty under S.122 of the Road Traffic Regulation Act 1984.



# THE BOLTON (REGULATION OF WAITING, LOADING AND UNLOADING) (CONSOLIDATION) ORDER 2015 and (ON-STREET DESIGNATED PARKING PLACES) (CONSOLIDATION) ORDER 2013 (HIGHFIELD ROAD) (AMENDMENT) (NO.XX) ORDER 2025

The Borough Council of Bolton, in exercise of their powers under Sections 1(1), 2(1) to (3) and 4(2), 32 and 45 of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Constable of Greater Manchester Police in accordance with Part III of Schedule 9 of the said Act of 1984, hereby make the following Order:-

- 1. The Interpretation Act 1978, shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2. The Bolton (Regulation of Waiting, Loading and Unloading) (Consolidation) Order 2015, means the Bolton (Regulation of Waiting, Loading and Unloading) (Consolidation) Order 2015, or as that (Consolidation) Order 2015, re-made or re-consolidated.
- 3. The Bolton (On-Street Designated Parking Places) (Consolidation) Order 2013 means the Bolton (On-Street Designated Parking Places) (Consolidation) Order 2013, or as that (Consolidation) Order 2013, re-made or re-consolidated.
- 4. The Bolton (Regulation of Waiting, Loading and Unloading) (Consolidation) Order 2015, shall have the effect as though the sides of lengths of road specified in Part 1 of the Schedule to this Order were deleted from Schedule 3 to that Order.
- 5. The Bolton (Regulation of Waiting, Loading and Unloading) (Consolidation) Order 2015, shall have the effect as though the sides of lengths of road specified in Part 2 of the Schedule to this Order were included in Schedule 3 to that Order.
- 6. The Bolton (On-Street Designated Parking Places) (Consolidation) Order 2013, shall have the effect as though the sides of lengths of road specified in Part 3 of the Schedule to this Order were included in Schedule 3 Part 1 to that Order.
- 7. This Order shall come into operation on the XX and may be cited as The Bolton (Regulation of Waiting, Loading and Unloading) (Consolidation) Order 2015 And (On-Street Designated Parking Places) (Consolidation) Order 2013 (Highfield Road) (Amendment) (No.XX) Order 2025.

Highfield Road	South	from a point 32 metres west of its junction with Derwent Road, to a point 15 metres east of its junction with Derwent Road	NWAT

### Part 2

Road Name	Side of Road	<u>Length</u>	Restriction
Highfield Road	South	Both sides of the island separating the access road from the main carriageway, from its intersection with the extended eastern kerbline of Derwent Road, for a distance of 15 metres in an easterly direction.	NWAT
Highfield Road	South	The access road south of the main carriageway, from its intersection with the extended eastern kerbline of Derwent Road, for a distance of 10 metres in an easterly direction.	NWAT
Highfield Road	South	from its intersection with the extended western kerbline of Derwent Road, for a distance of 32 metres in a westerly direction	NWAT

### Part 3

### **Electric Vehicle Parking Place**

Road Name	Location
Highfield Road	The access road south of the main carriageway, from a point 10 metres east of its intersection with the extended eastern kerbline of Derwent Road, for a distance of 14 metres in an easterly direction.
Highfield Road	The access road south of the main carriageway, from a point 30 metres west of its intersection with the extended western kerbline of Anchor Lane, for a distance of 14 metres in a westerly direction.
