**Long Stay (No max stay)**

Brightmet Street, Clive Street, Gartside Street, Gas Street, Palace Street and Dawson Lane.

The Borough Council of Bolton, in exercise of its powers under Sections 4, 5, 32, 35,45,46, 47,49 and 53, of the Road Trame Regulation Act 1984 and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Constable of Greater Manchester Police in accordance with Part III of Schedule 9 of the said Act of 1984, hereby make the following Order:-

1. The Interpretation Act 1978, shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
2. The Bolton (On-Street Designated Parking Places) (Consolidation) Order 2013, means The Bolton (On-Street Designated Parking Places) (Consolidation) Order 2013, or as that (Consolidation) Order 2013, re-made or re-consolidated.
3. The Bolton (On-Street Designated Parking Places) (Consolidation) Order 2013 shall have the effect as though the sides of lengths of road specified in Part 1 of the Schedule to this Order were removed from Schedule 3 Part 1 to that Order and replaced with Part 2 of the Schedule to this order.
4. This Order shall come into operation on the 24<sup>th</sup> June 2025 and may be cited as The Bolton (On-Street Designated Parking Places) (Consolidation) Order 2013 (Amendment) (No.9) Order 2025.
