

CHORLEY NEW ROAD / DE HAVILLAND WAY, HORWICH (BEEHIVE ROUNDABOUT) TEMPORARY CLOSURES

THE BOROUGH COUNCIL OF BOLTON
ROAD TRAFFIC REGULATION ACT 1984 S.14

The Council intends to make an order, operative from 14 July 2025 for 2 weeks approx. between the hours of 7pm and 5am, the effect of which will be to close sections of 'The Beehive Roundabout' to allow resurfacing works to take place in the phases listed below.

Phase A

Vehicles travelling eastbound (Chorley New Road - from Horwich towards Bolton) will be unable to access the roundabout.

Alternate route will be via Scholes Bank, Bolton Rd, Westhoughton Rd, Chorley Rd, Blackrod Bypass, Chorley Road.

Phase B

Vehicles travelling eastbound on Chorley New Road from Horwich towards Middlebrook will be unable to use the eastern sector of the roundabout. A short diversion (50m) will be created using the access slip south of Austins Lane.

Phase C

Closure of De Havilland Way (Southbound traffic) from Chorley New Rd to Mansell Way.

Vehicles travelling on Chorley New Road (eastbound) towards Bolton will be unable to turn right onto De Havilland Way.

Vehicles travelling on Chorley New Road (westbound) towards Horwich will be unable to turn left onto De Havilland Way.

Alternate route will be Chorley New Road, Beaumont Rd, Wigan Rd, Snydale Way, Chorley Rd.

The Order will end after 18 months or on completion of the works whichever first occurs.

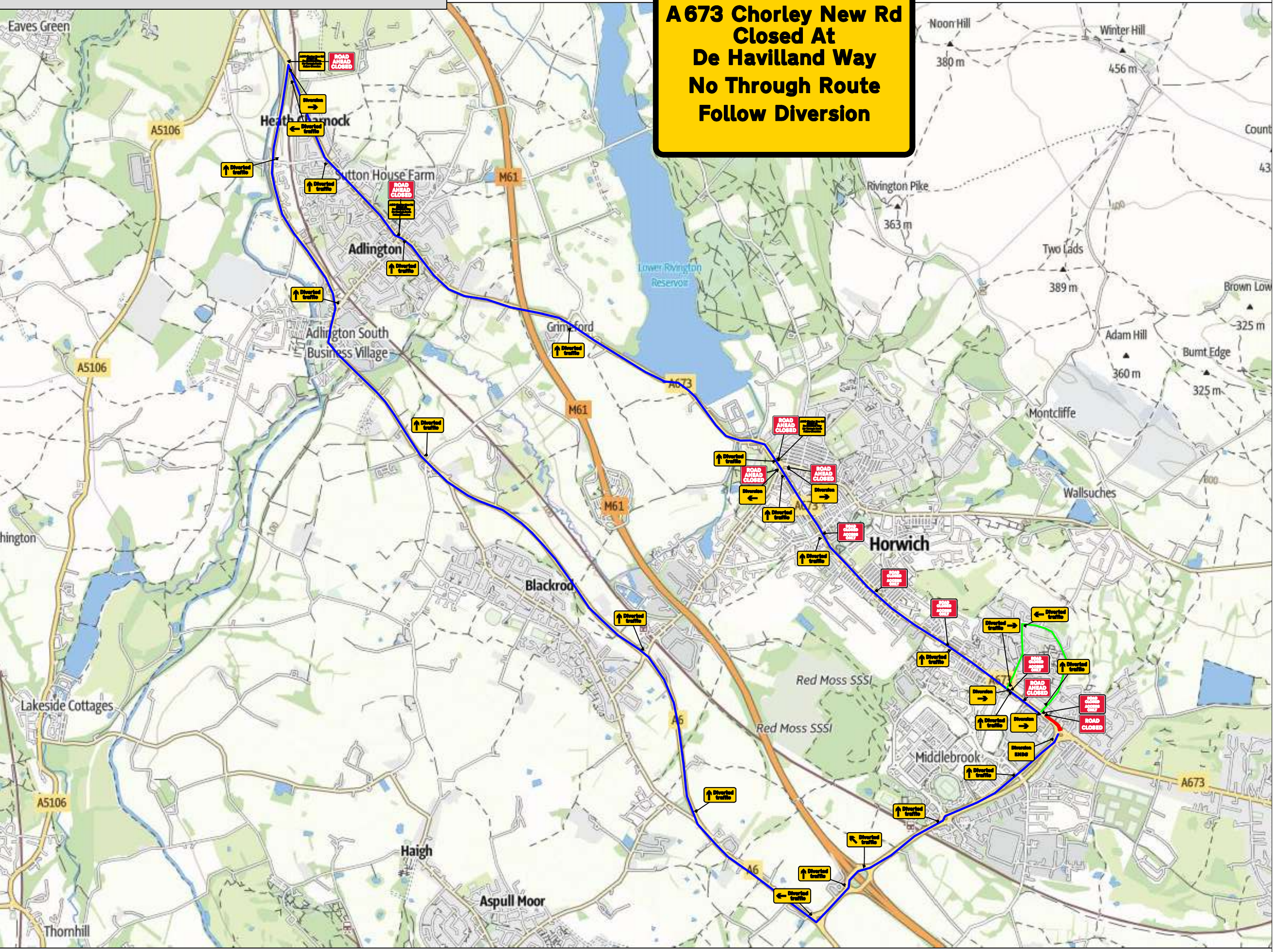

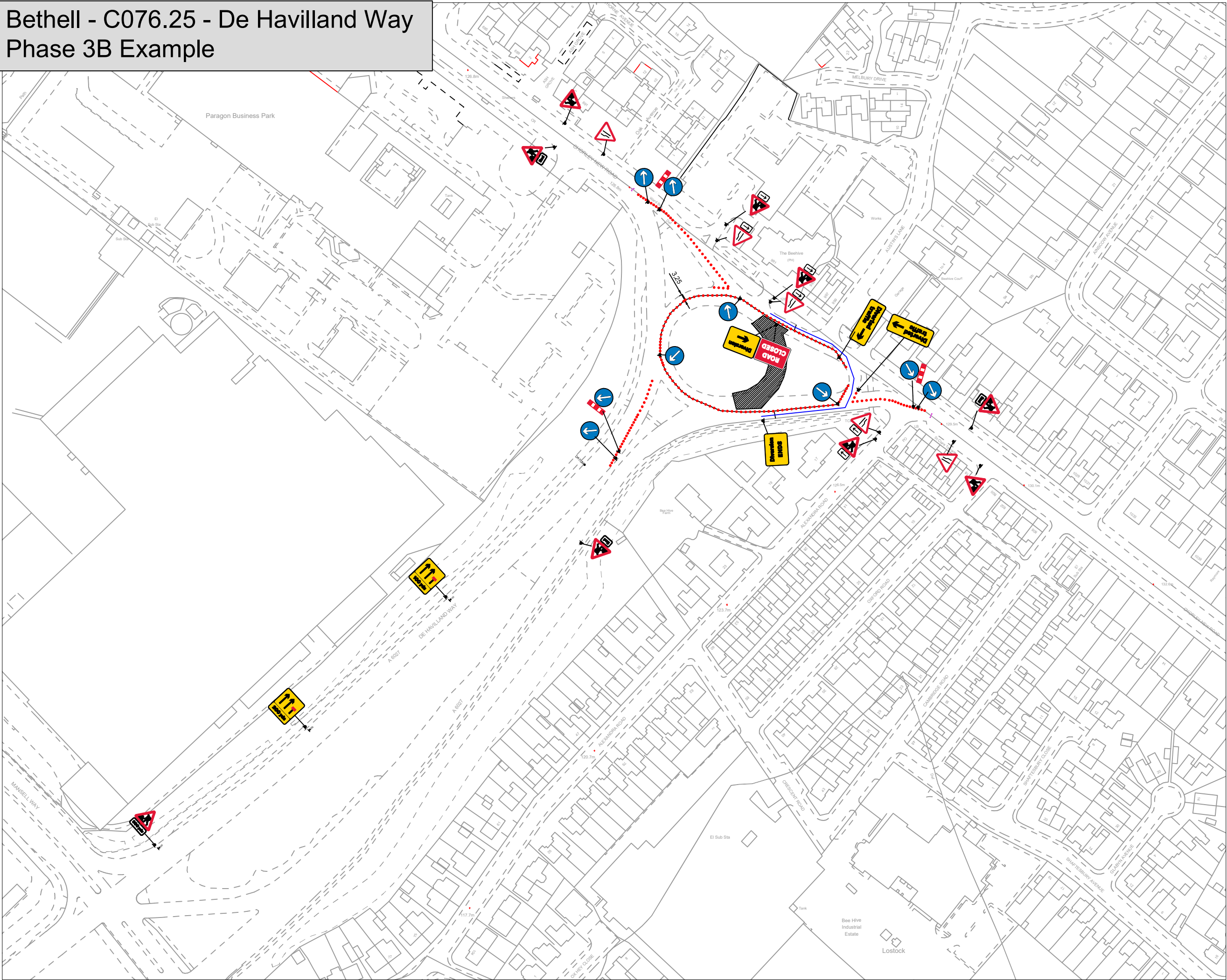
