#### 1. Introduction and Background

- 1.1. The Gambling Act (Act) received royal assent in April 2005. It consolidated the regulation of casinos, bingo, gaming machines, lotteries, betting, and remote gambling into one Act.
- 1.2. The Act established a non-departmental public body, the 'Gambling Commission'. The Gambling Commission is responsible for advising both central and local government on issues relating to gambling.
- 1.3. The Gambling Commission issues operating licenses to organisations (required for operating gambling premises) and personal functional licences to individuals. A personal functional licence is required by an individual who performs any task that enables them to influence the outcome of gambling or receives payment of money in connection with gambling, such as a dealer or croupier.
- 1.4. The Gambling Commission (under section 25 of the Act) issue guidance to licensing authorities on the discharge of their functions under the Act. This guidance deals primarily with matters intended to assist licensing authorities in the development of their 'Statement of Principles', which is commonly referred to as 'The Gambling Policy'. The guidance sets out the principles that must be applied by the licensing authority in exercising its functions under the Act.
- 1.5. Under the Act the Council is the Licensing Authority and is responsible for issuing premises licences, permits, and temporary use notices (premises where it's proposed that gambling should take place). The Licensing Authority has also continued to be responsible for the registration of small society lotteries.
- 1.6. Section 349 of the Act requires the Licensing Authority to review, consult and publish a Statement of Principles every three years. The Licensing Authority adopted the current Statement of Principles in 2022.
- 1.7. The Statement of Principles details the approach taken by the Licensing Authority in carrying out its functions under the Act, the standards expected of licence holders and applicants applying for premises licences, permits, and other permissions for example lottery registrations.
- 1.8. The Act has significantly transformed the gambling landscape with the rise of technology and online gambling services. In response, the Government initiated a comprehensive review of the Act. The Department for Culture, Media and Sport (DCMS) published its gambling <a href="white-paper">white paper</a> in April 2023, which set out the government's plans for modernising the regulation of the gambling sector. A series of key proposals specifically relating to the land-based gambling sector were outlined in the white paper, including measures to adjust outdated regulatory restrictions applying to the sector.
- 1.9. The gambling white paper contains over 60 proposed policy measures, to be delivered by a mixture of different stakeholders, making it a highly complex policy initiative. The policy measures have different timeframes and implementation processes, and potentially intersecting outcomes and impacts.
- 1.10. From 26<sup>th</sup> July to 4<sup>th</sup> October 2023, DCMS conducted a public <u>consultation</u> on these measures. Following analysis of the evidence submitted, the government intends to implement the following measures:
  - a) **Relaxation on casino rules**: allowing 1968 Act casinos to increase the number of their gaming machines to 80 if they meet the size requirements of a Small 2005 Act casino and allowing smaller 1968 Act casinos more than 20 machines, on a pro rata basis commensurate to their size, and permitting betting in all casinos.

- b) **Machines in arcades and bingo halls**: allowing a 2:1 ratio of Category B to Category C and D gaming machines in arcades and bingo halls, implemented on a device type basis.
- c) Cashless payments on gaming machines: removing the prohibition on the direct use of debit cards on gaming machines, subject to the introduction of appropriate player protection measures.
- d) Introduction of a legal age limit of 18 for certain gaming machines: protecting children and young people by banning anyone under the age of 18 from playing low stake Category D slot-style machines that pay out cash.
- e) **Licensing authority fees**: increasing the maximum chargeable premises licensing fees by 15%.
- 1.11. In July 2025, the DCMS introduced the first measures and relaxed the casino rules outlined at a) above. Both casino premises in Bolton have completed variations to their licences to enable them to benefit from the changes.
- 1.12. On 15<sup>th</sup> October, the DCMS launched a public consultation on its proposals to update the regulatory framework for Category D machines and Bingo Premises Licences. The consultation outlines proposals to make changes to stakes and prizes for Category D machines and to update the licensing framework for the bingo sector. The consultation closes at 23:59 on 9<sup>th</sup> January 2026 Consultation on Category D gaming machines and licensing for bingo premises GOV.UK

# 2. Report Details

- 2.1. The current Statement of Principles marked the first time that a unified Statement of Gambling Principles has been collaboratively approved across Greater Manchester at a local level. These principles were developed by the ten Greater Manchester Local Authorities who took the opportunity to think differently about the potential impacts of gambling across the city region, with the shared aim of preventing and reducing the negative impacts of gambling on individuals, families, and communities.
- 2.2. As part of the innovative public service reform and population health agenda, Greater Manchester are working with partners across each of the districts to ensure that gambling is a safe and enjoyable activity for all who choose to take part. The priorities are:
  - Developing an understanding of gambling related harms;
  - Improving access to high quality treatment and support;
  - Supporting interventions to prevent gambling from becoming a harmful activity; and
  - Engaging with people and communities to co-design the work.

#### 3. Options

- 3.1. The Council is required by statute to review and publish a Statement of Principles.
- 3.2. The Committee is asked to note the information contained in the report and to approve consultation on the Statement of Principles. The Statement of Principles is attached as a separate document at Appendix A. Appendix B outlines the sections and page numbers where changes are proposed (these are also highlighted in yellow in Appendix A). Details on the consultation and consultees are outlined in section 6 below.
- 3.3. Following conclusion of the consultation exercise, a further report summarising comments from consultees will be shared with the Committee.

3.4. Following consideration of the comments and any subsequent amendments to the Statement of Principles, the Committee will be asked to recommend to a future meeting of the Council that the Statement of Principles be adopted.

#### 5. Equality Impact Assessment (EIA)

### 6. Consultation and Engagement

- 6.1 The requirement to review the Statement of Principles is accompanied by a statutory requirement to formally consult. The normal consultees are outlined below, however the list can be broadened to include additional consultees who can provide further insights, for example Public Health.
- Once the Committee has approved the consultation, Section 349 of the Act requires the Council to consult with the following groups:
  - The Chief Officer of Police:
  - One or more persons who appear to the authority to represent the interest of persons carrying on gambling business in the Bolton area; and
  - One or more persons who appear to the authority to represent the interest of persons who are likely to be affected by the exercise of Bolton Council's functions under the Gambling Act 2005.
  - 6.3 It's intended to consult on the proposed Statement of Principles as follows:
    - The consultation and proposed policy will be published on the Council's website.
    - A communication will be sent to the following persons/organisations informing them of the consultation and directing them to the Council's website:
      - o The Chief Officer of Greater Manchester Police;
      - Local Area Forums;
      - o Companies who have betting, bingo and casino premises in the Bolton area;
      - Local Children's Safeguarding Partnership;
      - Gamcare and Gamblers anonymous;
      - o Public Health.
- 6.4 It's proposed that a consultation period of 6 weeks is undertaken.

## 7 Vision 2030

7.1 The Vision 2030 Strategy highlights that the Council want businesses to work and invest in the borough, and through their corporate social responsibility maximise social value opportunities, whilst creating good inclusive and sustained employment across the system. Whilst striving for stronger, cohesive, more confident communities in which people feel safe, welcome, and connected. The proposals within this report contribute to this strategic council aim.
