

THE BOLTON (REGULATION OF WAITING, LOADING AND UNLOADING) (CONSOLIDATION) ORDER 2015 (ELDERCOT ROAD) (AMENDMENT) (NO.XX) ORDER 2025

The Borough Council of Bolton, in exercise of their powers under Sections 1(1), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Constable of Greater Manchester Police in accordance with Part III of Schedule 9 of the said Act of 1984, hereby make the following Order:-

- 1. The Interpretation Act 1978, shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2. The Bolton (Regulation of Waiting, Loading and Unloading) (Consolidation) Order 2015, means the Bolton (Regulation of Waiting, Loading and Unloading) (Consolidation) Order 2015, or as that (Consolidation) Order 2015, re-made or re-consolidated.
- 3. The Bolton (Regulation of Waiting, Loading and Unloading) (Consolidation) Order 2015, shall have the effect as though the sides of lengths of road specified in Part 1 of the Schedule to this Order were included in Schedule 3 to that Order.
- 4. This Order shall come into operation on the XX and may be cited as The Bolton (Regulation of Waiting, Loading and Unloading) (Consolidation) Order 2015 (Eldercot Road) (Amendment) (No. XX) Order 2025.

Elderfield Road	Both	From its intersection with the extended southern kerbline of Eldercot Road for a distance of 15 metres in a southerly direction.	NWAT
Hulton Lane	East	From a point 20 metres north of its intersection with the extended northern kerbline of Eldercot Road to a point 15 metres south of its intersection with the extended southern kerbline of Eldercot Road.	NWAT
Hulton Lane	West	From a point 10.5 metres north of its intersection with the extended northern kerbline of Chip Hill Road to a point 15 metres south of its intersection with the extended southern kerbline of Chip Hill Road.	NWAT
Eldercot Road	Both	From its intersection with the extended eastern kerbline of Hulton Lane for a distance of 15 metres in an easterly direction.	NWAT
Chip Hill Road	North	From its intersection with the extended western kerbline of Hulton Lane for a distance of 10 metres in a westerly direction.	NWAT
Chip Hill Road	South	From its intersection with the extended western kerbline of Hulton Lane for a distance of 25 metres in a westerly direction.	NWAT
