This notice has been prepared in accordance with the Planning and Compulsory Purchase Act 2004 (as amended) and the Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended)

Notice is hereby given that, (in accordance with regulations 11, 12, 14 and 35 of the Town and Country Planning (Local Planning) (England) Regulations 2012 and Section 23 of the Planning and Compulsory Purchase Act 2004 (as amended), Bolton Council has adopted the West of Wingates Industrial and Warehousing Strategic Masterplan Supplementary Planning Document with effect from 08 June 2026.

Any person with sufficient interest in the decision to adopt the West of Wingates Industrial and Warehousing Strategic Masterplan Supplementary Planning Document may make an application to the High Court for permission to apply for judicial review of that decision.

Any such application to the High Court must be made promptly and in any event not later than 3 months after the date on which the supplementary planning document was adopted.

In relation to Section 23(1) of the Planning and Compulsory Purchase Act 2004 and Regulation 11(2)(b) of the Town and Country Planning (Local Planning) (England) Regulations 2012, modifications have been made to the Supplementary Planning Document following consultation on the draft document. These are set out in the Schedule of Consultation Responses.

In accordance with regulations 11, 12, 14 and 35 of the Town and Country Planning (Local Planning) (England) Regulations 2012, as soon as practicable after the date of adoption (08 June 2026), the following documents will be made available for inspection via the council's website:
